



COMPSOFT PLC – LIMITED USE SOFTWARE LICENCE AGREEMENT

Your right to use the product in this package or electronic download is subject to the terms and conditions contained in this Agreement. The package or download contains programs and related documents and files (the Software); by installing or otherwise copying the Software you signify your acceptance of these terms and conditions. Therefore please read them carefully first.

1 TITLE

1.1 All copyrights and other intellectual property rights in the Software and rights in any proprietary information it may contain are, and will remain, the sole property of Compssoft (or its suppliers).

1.2 Compssoft also retains ownership of any physical media (the Media) on which the Software is supplied and you must return the Media to Compssoft upon termination of this Agreement for any reason.

1.3 The Software is designed for use on multi-user computers or computer networks and includes technical features designed to limit access to a specific number of users at any one time. THE NUMBER OF USERS FOR WHICH A PARTICULAR COPY IS DESIGNATED (the Intended Number) IS STATED ON THE MEDIA SUPPLIED OR IN THE EMAIL DELIVERING THE SOFTWARE. If you wish more than this number of users to have simultaneous access to the Software, please contact your dealer or Compssoft. Please note that additional licence fees are payable for additional users.

1.4 Compssoft reserves the right to change and improve the Software without notice. (If you wish to have the Software updated and maintained by Compssoft you may enter into an appropriate maintenance agreement with Compssoft, in which case Compssoft will supply error corrections and improvements to and assistance with use of the Software).

2 HOW YOU MAY USE THE LICENSED SOFTWARE

2.1 No licence for use of the Software shall be binding on Compssoft unless such licence is subject to these terms and conditions and no other. You are licensed to use the Software only in the manner and only for the purposes described below and you agree not to use or copy the Software in any other way.

2.2 You may use the server or single-user component of the Software on a single computer, and the client component of the Software on a network of computers, in the manner and for the purpose described in the documentation. For this purpose you may:

2.2.1 copy the Software from the Media on to the permanent storage of your computer, or on to one of the computers on your network; and

2.2.2 make copies which are created in the normal course of using the Software and which are by their nature transient; and

2.2.3 make a single back-up copy of the Software in addition to the copy enclosed BUT you must not use or allow the back-up copy to be used for any purpose other than back-up.

2.3 You may not allow more than the Intended Number of users to have simultaneous access to the Software at any time, whether or not this may be technically possible.

2.4 You may not modify, decompile or disassemble the Software except insofar as the law may permit you and you hereby agree to adhere to any such law.

2.5 You agree to keep the Software, and all copies of it, in your possession and under your control unless or until you return it to Compssoft.

2.6 You agree to return the Software on the Media to Compssoft:

2.6.1 when you no longer require it for your use; or

2.6.2 on termination of your licence to use the Software, and to destroy any back-up copy which you may have made and any other copies of the Software in your possession or under your control.

2.7 If the Software contained within this package or electronic download is Equinox Publisher for Windows you can through operation of the Software create and distribute two types of licence: 30-day



limited single-user licences for demonstration purposes only, and inactivated single-user executive runtime licences which must be individually activated by Compssoft before use. You agree not to use or copy the licences thus created except as permitted in section 2 of this Agreement.

3 TERMINATION OF THE LICENCE

3.1 The permissions granted to you under this Agreement are personal to you and may not be transferred, assigned or otherwise disposed of. If you attempt to transfer, assign or otherwise dispose of these permissions your licence to use the Software is terminated.

3.2 If you use the Software in any way that will result in your breach of 3.1 above or if you fail to comply with any provision of this Agreement your licence to use the Software is terminated immediately.

4 COMPSOFT'S WARRANTIES

4.1 Compssoft warrants to you that the Software and the Media will conform to the release version current at the date when you take supply.

4.2 NOTE that Compssoft will not provide any error correction, improvements or assistance after a 90-day period unless under the terms of a Maintenance Agreement as described in Clause 1.4.

4.3 Compssoft gives no warranties, conditions, representations or other terms, expressed or implied, relating to the performance, quality or fitness for use of the Software other than those expressed in this Clause 4. Without limiting the above:

4.3.1 Compssoft DOES NOT WARRANT that the functions of the Software will meet your requirements; and

4.3.2 although Compssoft has used reasonable efforts to minimise defects or errors in the Software, Compssoft DOES NOT WARRANT that Software operations will be error free or uninterrupted; and

4.3.3 nothing in clause 4 or 5 does or shall affect your statutory rights as a consumer, that is to say someone acquiring the Software otherwise than in the course of a business and not holding themselves out as acquiring the Software in a course of a business.

5 LIMITATION OF LIABILITY

5.1 Compssoft's liability for any loss (whether direct or consequential) or damage of any kind (other than death or personal injury) arising from any faults in the Software or from its use, whether such loss or damage is caused by negligence or otherwise, shall be limited to the price paid for the Software.

5.2 YOU ASSUME THE RISK OF ANY AND ALL DAMAGE OR LOSS FROM USE, OR INABILITY TO USE THE SOFTWARE.

5.3 No provision in this Agreement shall be taken as excluding or restricting or attempting to exclude or restrict any liability for death or personal injury arising from the negligence of Compssoft.

5.4 This Clause 5 survives termination of the licenses granted to you or termination of this Agreement for any reason.

6 GOVERNING LAW

This Agreement shall be governed by and constructed in accordance with English Law. YOU AGREE THAT YOU HAVE READ THIS AGREEMENT AND UNDERSTAND IT AND THAT BY INSTALLING, TESTING OR USING THE SOFTWARE YOU AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS. YOU FURTHER AGREE THAT THIS AGREEMENT IS THE COMPLETE AND EXCLUSIVE STATEMENT OF THE RIGHTS AND LIABILITIES OF THE PARTIES TO IT. THIS AGREEMENT SUPERSEDES ALL PRIOR WRITTEN AGREEMENTS PROPOSALS OR UNDERSTANDINGS, ORAL OR WRITTEN, OR ANY OTHER COMMUNICATION BETWEEN US RELATING TO THE SUBJECT MATTERS OF THE AGREEMENT.
